- 3. THE FAIR ASSOCIATION OR ITS BOARD, OFFICERS, VOLUNTEERS MAY NOT BE HELD LIABLE FOR ANY ACCIDENTS, INJURIES OR OTHER FOR VENDORS, EXHIBITORS OR GUEST.
- 4. VEHICLE TRAFFIC OR PARKED VEHICLES ARE NOT PERMITTED ON GROUNDS DURING OPENING HOURS. GATES WILL BE CLOSED TO TRAFFIC @ 4:30 PM
- 5. SECURITY IS ON SITE DURING THE ENTIRE EVENT; HOWEVER, THE ASSOCIATION IS NOT RESPONSIBLE FOR THEFT OR LOSS OF ITEMS OR OTHER SECURITY ISSUES.
